Due to the Complexity of work only eligible bidders with the following key qualifications should participate in this bidding and shall attached the scanned copy of below stated experience and equipment (owned/leased) during submission of bid document and these documents shall be used as eligibility criteria during evaluation: Minimum Construction Experience in Key Activities: At least 1 Contract of RCC Framed Building having M20 Grade Concrete work of 172 cubic meter and Reinforcement work of 26 metric tonne.in a single project within the last ten (10) years,

Equipment: One cement Bag Concrete Mixture (1 Number having drum capacity of 400-500 liters) and Needle Vibrator (3 Numbers)

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 4,50,000, which shall be valid for 30 days beyond the validity period of the bid.
- 7. The bidders are advised to visit the site & assess the actual site condition before submission of bid document.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
